EARLY VOTING INFORMATION

Early Voting allows all registered voters to cast their ballot prior to Election Day between Thursday, Sept. 27 and Monday, Nov. 5 by voting at pre-designated sites named by the County Clerk. By state law, for the 2018 General Election, early voters must be registered voters and are not required to show valid picture ID showing their current voter registration address. No excuse or reason is necessary to take advantage of Early Voting. Any vote cast during the Early Voting period is final and may not be revoked. Early Voters are not eligible to vote on Election Day.
