## **A Message to Voters**

t is my pleasure to provide Macoupin County voters with this 2024 General Election Information and Voter Guide. In addition to sample ballots, the Guide includes information about voter registration, voting procedures, early voting and voting by mail. The Voter Guide is part of my office's ongoing effort to ensure voters have all the information they need to participate in the 2024 General Election. In addition to this printed guide, our efforts to inform voters include a robust internet presence where voters can view sample ballots, look up their polling places and learn about vote-by-mail and early voting options. Our goal is to make voting an easy and convenient experience for everyone.

It may be a cliche to say this election is vitally important, but it is. Truthfully, all elections are important. Voting is the foundation of our representative democracy, and the warranty that protects our freedom. The ability to choose our own political leaders is uniquely American, and voter participation is the key to having a responsive, responsible government.

In the last Presidential Election, in 2020, more than 75 percent of Macoupin County's registered voters cast ballots despite the challenges presented by the COVID-19 pandemic. By most standards, that was an admirable turnout. But it meant nearly a quarter of our registered voters chose to not participate. When I think back to the days before any of us were born, I realize that voters once had to ride on horseback, hitch up a horse and buggy, or even walk, often in inclement weather, just to make their mark on a ballot and have their voices heard. These days, casting a ballot on Election Day is a matter of

hopping the car and driving a few blocks or a few miles to reach a polling place to cast a ballot. Moreover, we have early voting and vote-by-mail options that did not exist a century ago. Casting a ballot has become so easy that is hard to imagine

**ON THE COVER:** Using proceeds from a federal Centers for Election Excdellence grant, the Macoupin County Board authorized establishing a County Voting Center last year at 227 E. First South Street in Carlinville. Located adjacent to the Old County Jail, directly across the street from the Courthouse, the new facility not only provides a central location for early voting, but also improves election secure by providing a secure location for storing and testing voting machine, and providing space for meetings and election judge training. why anyone would not participate..

In addition to helping to elect a new U.S. President, voters who participate in the General Election also will cast votes for U.S. Congressional Representative in the 13th District, and State Representatives to the General Assembly in the 100th and 108th State Representative districts. At the county level, voters will vote for Circuit Clerk, Coroner and State's Attorney, as well as County Board members in four County Board districts. Voters also will choose judges to fill vacancies in the 4th Appellate Judicial District and a resident judge in the 7th Judicial Circuit.

Apart from the political races, voters will voice their opinion on three proposed amendments to the Illinois Constitution. Each of the three referendums are non-binding but the results will guide the state legislature in the future. One of the initiatives asks voters to advise the legislature on whether or not to require health insurers who offer full coverage for pregnancies to also cover medically assisted reproductive treatments, including in vitro fertilization. A second question asks voters to advise the legislature on whether or not to amend the Illinois Constitution to create an additional three percent tax on income greater than \$1 million with the revenue generated dedicated to property tax relief. Finally, the third question will ask voters to advise the legislature on whether or not to establish civil penalties for a candidate who interferes or attempts to interfere with an election worker's official duties.

I'm proud to say election results in Macoupin County have never been questioned in the time I have served as your County Clerk. That's testament to the hard work and dedication of our Elections Office staff and election judges who commit themselves to training and put in long hours of public service on Election Day and/or during early voting opportunities, as well as political leaders from both major parties. In Macoupin County, we use up-to-date voting technology that electronically tabulates votes but also maintains a paper trail to confirm election results should they ever come under question. Macoupin County elections also are safe from cyber-attacks; our voting machines and tabulating equipment are not connected to the internet in any way. For us, maintaining the integrity of our elections is always Job No. 1.

As part of our continuing effort to improve our service to voters and candidates, the County Board authorized establishing a new Macoupin County Voting Center adjacent to the Old Macoupin County Jail to provide a central location for early voting and election administration. If you have further questions or need additional information, I encourage you to contact my office at (217) 854-3214, extension 918, or visit our comprehensive election website at www.macoupinvotes.gov. The state of the art website allows voters to check the status of their voter registration, find the polling place for their precinct, view sample



ballots and obtain other information. On election night, the website will be updated regularly with election results for Macoupin County so voters will know the outcome of local races and ballot issues as soon as ballots are counted.

From finalizing ballots and responding to vote-bymail requests to setting up polling places and vote counting equipment, administering any election is a mammoth undertaking. As your County Clerk, it has again been my pleasure to work with staff members, party officials, candidates and public officials to make sure every aspect of the 2024 General Election runs smoothly.

## **Voter Bill** of Rights

### You have the right to:

- Cast your ballot in a non-disruptive atmosphere free of interference.
- Vote if you're in line at the polling place by 7:00 p.m.
- Be a provisional voter if there is a question about your registration status or your eligibility to vote in the election.
- ✤ Vote a federal ballot at your old polling place if you have moved within 30 days of the election.
- Request assistance in voting, if needed.
- Bring this voter's guide or sample ballots into the voting booth, but take them with you when you finish voting.
- Protect the secrecy of your ballot by using the ballot secrecry folder provided.
- Receive a new ballot if you make a mistake or change your mind.
- Check for voting errors (overvotes) after marking your ballot in a private and independent manner.
- Have your ballot counted fairly and impartially.
- If you believe these rights have been violated, call the Macoupin County Clerk's Office at (217) 854-3214.

## **Am I Eligible to Vote?**

### Am I Eligible to Vote?

In order to be eligible to vote in Macoupin County, you must register. The County Clerk's Office processes all voter registration applications for Macoupin County residents. The last day to register for this Election is Oct. 8. See the 'Grace Period Balloting' section on page 6 for more information.

### Who Can Register to Vote?

You may register to vote if you are a U.S. citizen and

18 years of age by date of next election and lived at your current Macoupin County address

for 30 days immediately prior to following: the next election.

### Two forms of identification are required when registering with a deputy registrar.

At least one of the two forms must show your current name and address.

Only one form of identification may be a piece of mail postmarked within the past 30 days which has been addressed and delivered to you.

## **Voter Information Changes**

### Keep us up to date with you!

#### Update important voting information quickly prior to Election Day

Address Change – Any time you move, you have to update your registration. You may do this by visiting MacoupinVotes.gov, calling our office, completing a Illinois Voter Registration Application form, or providing a signed written notice that includes your date of birth and signature.

**Name Change** – If you get married or have a legal name change, you have to update your registration. You can do this by completing an Illinois Voter Registration Application form or by visiting MacoupinVotes. gov.

**Signature Change/Update** – If your signature has changed dramatically, you need to update your registration. You can do this by completing an Illinois Voter Registration Application form or signing the back of your Voter Information Card.

**Voter Information Cards** – Your voter information card is routinely mailed to confirm new registration, voter updates or changes in polling places.

New Voter Information Cards were mailed to every voter in the county in January. State law requires the Election Office to mail out voter cards to all voters every two years. This voter file maintenance was the seventh done since October 20211. There was a five-year

break before October 2011 in which no voter file maintenance was completed.

The maintenance mailing is done to ensure only valid registrations for voters are listed in the voter file.

This has multiple goals:

- Makes sure a voter's registration is complete and up-to-date before the voter tries to vote
- Cleans the voter file of no longer valid registrations
- Speeds up Election Day sign-in process by shortening the list of voters given to judges.
- Reduces costs in the election budget by requiring less ballots and supplies to be printed.

Every registered voter should have received a new card. The new card should be checked to make sure the name and address of the voter is up to date. If it is not, the voter will need to change their registration before the next election.

Voters are also reminded that if they do not receive a card but feel they are registered, there are a couple of common issues that might explain why they did not receive a card. Their registration information was not updated after moving to a new address or they had a P.O. Box listed on their registration that they no longer use.

Voters are asked to return any cards sent to a person who no longer resides at that address. All that is required is your signature and a note stating the voter no longer lives at that residence so the voter's registration can be removed.

## If I Didn't Register or Forgot to Change My Registration Before the Deadline, Can I Still Vote?

If you were unable to register to vote or change your address prior to the close of registration, you can still register and vote through grace period voting. The close of registration for this election was is Oct. 8.

Grace period individuals may register to vote or change their address starting Oct. 9 through Election Day at the Macoupin County Voting Center.

Grace period voting is only available at the Macoupin County Voting Center, east of the Old Jail. Hours are Monday through Friday, 8:30 a.m. to 4:30 p.m. Two forms of identification are required to register or change your registration during grace period voting:

- At least one of the two forms must show your name and current address,
- And only one form of identification may be a piece of mail addressed and delivered to you.

The second form must show your name. These forms of identification shall include, but not be limited to:

- Driver's License
- Social Security Card
- Birth Certificate
- Employee ID

- Student ID Card
- Credit Card
- Library Card
- Insurance Card
- ✤ Utility Bill
- Checkbook
- Telephone Book
- State ID Card

Grace period voters must vote on the same day they register to vote. They may not vote at the polls on Election Day.

### Vote at Your Precinct on Election Day

Election Day is your last chance to vote! To find your polling place, see 'Where Do I Vote on Election Day?' on page 10. Be sure we have your current information on your registration. See 'Am I eligible to vote?' on page 4 for more information.

Make sure to show up from 6 a.m. to 7 p.m. to vote. To avoid lines and congestion at your precinct, you may want to vote in the 10 a.m. to 4 p.m. non rush hour time frame of the day.



## **Constitutional Questions**

The Illinois General Assembly is seeking voter input on three potential amendments to the state constitution. Each of the three referendums are non-binding but the results will guide the state legislature regarding the amendments.

The constitutional amendment questions will appear at the top of your ballot.

Voters are asked to advise legislators on each of the following constitutional issues.

 Whether or not health insurers who offer full coverage for pregnancies should be required to also cover medically assisted reproductive treatments, including in vitro fertilization.

- Whether or not the Illinois Constitution should be amended to create an additional three percent tax on incomes greater than \$1 million with the new revenue generated dedicated to property tax relief.
- Whether or not to establish civil penalties for a candidate who interferes or attempts to interfere with an election worker's official duties.

Voters may vote only on the constitutional amendments if they wish. In such instances, the vote tabulator will kick out the ballot as an "undervoted" ballot. An election judge will verify whether or not the voter intended to skip some or all of the political races. If the voter confrims his or her intent, the judge will override the tabulator to tabulate votes for the races or question for which the voter intended to cast a vote.

## What to Expect at the Polls

Voting should be a quick, satisfying experience if you follow a few simple steps. Here are some tips on what to expect at the polls on Election Day:

First, you are required to vote in the precinct where you live. Your voter information card shows your precinct number and polling place location. It can also be found on our website. The polls are open from 6 a.m. to 7 p.m. To avoid the heavy turnout times of 6 a.m. to 9 a.m. and 5 p.m. to 7 p.m., we suggest you vote between 10 a.m. – 4 p.m. to avoid long lines.

To ensure a quick process, any changes to your name or address since the last Election should be updated with the Elections Office prior to Election Day.

Election judge will ask your name and address, find your name in the poll book and ask you to sign both an application to vote and the poll book. Your application to vote will be numbered and your ballot will be initialed by an Election judge.

It is important that you review your ballot for accuracy prior to casting your ballot. Once your ballot has been accepted by the voting equipment, no further changes or corrections can be made.

If you have made a mistake, you can 'spoil' the ballot you have by giving it back to the judges and getting a new ballot. You can ask any questions you have to the Election judges.

- Utility bill
- Bank statement
- Government check

## **Voter Responsibilities**

Each registered voter in this state should:

- 1. Familiarize herself or himself with the candidates and issues.
- 2. Maintain with the Elections Office their registration with a current name and address.
- 3. Know the location of her or his poll-

ing place and its hours of operation.

- 4. Bring proper identification to the polling station in case it is needed.
- 5. Familiarize herself or himself with the operation of the voting equipment in his or her precinct.
- 6. Treat precinct workers with courtesy.

- 7. Respect the privacy of other voters.
- 8. Report any problems or violations of Election laws to the County Clerk's office.
- 9. Ask questions, if needed.
- 10. Make sure that her or his completed ballot is correct before leaving the polling place.

## **Casting Your Ballot**

## **Optical Scan Voting: As Easy as 1,2,3**

### **1. Receive your ballot**

Enter the polling place and give your name and address to an Election Judge. Complete and sign an Application to Vote. Upon verification, the election judge will give you:


- a paper ballot
- a privacy cover
- a pen

### 2. Enter the voting booth and mark your ballot

Enter the next available voting booth. To vote the optical scan ballot, completely fill in the oval to the left of the candidate or public question of your choice. Be sure to mark both sides of your ballot if needed. If you make a mistake marking your ballot, return it to an Election Judge to receive a new ballot.

### 3. Vote!

Cover your ballot with the privacy sleeve and insert the ballot into the ballot tabulator. The Optical Scan System complies with the Help Amer-



ica Vote Act (HAVA) to provide voters an opportunity to check for and correct ballot errors (for example, casting more votes for an office than allowed results in an overvote). If an error is detected, the system will gently beep and give you the option to accept the ballot as is (the overvoted office will not count) or you may return the ballot to an Election Judge and receivea new ballot

### **FYI...**

- The ballot tabulator will notify you if you have overvoted an office or undervoted an office. Many voters intentionally skip offices which they do not care to vote in, but rarely intentionally vote for more candidates than allowed in any given office. You can either count the ballot as is or go back and check your ballot.
- The ballot tabulator will notify you if you have inserted a blank ballot or one that it perceived to be blank because it was not marked properly.
- The "paper trail" provided by this system of voting is not a receipt for the voter, but instead an actual ballot which can be recounted when necessary to insure the integrity of the system.

## **Vote By Mail Now Permanent**

The state has approved giving voters the choice of receiving a mail ballot each election without applying each time.

Voters wanting to be placed on the permanent vote by mail list are required to apply for that list. Once they apply, they will remain on the list and have a ballot mailed to them each election going forward. If the voter requests to be removed from the list, there is a change to their registration, or they move out of county, they will be removed from the list and no longer receive a ballot in future elections.

Those wanting to apply can choose to just apply to receive a ballot at general elections and consolidated elections or they can choose to also receive a primary ballot for the party they put on their application each primary, as well as general elections and consolidated elections.

"I'm very happy that voters who have been voting by mail for years and years will now have the option of requesting a ballot automatically if they so choose," Duncan said. "I'm all for giving voters more choices on how they want to vote. For those who only want to vote at their polling place on Election Day, they can still do that. For those who do apply to vote by mail each election, this is an option that may make sense for you."

This will be more cost-effective and efficient for elections going forward. There are quite a few voters in Macoupin who have voted by mail each election for many years. Each Election, the Election office has probably mailed them an application, and they've mailed it back to get their ballot. While it's not a lot of postage and costs, eliminating that step by that voter going on the permanent mail ballot list does save money. It also helps our Election office since they will have a head start on vote by mail ballot mailing since it will be known going in how many permanent mail ballots are going out, and can get them to voters right away.

## **Vote By Mail Ballot Processing**

### How do we process a voter's Vote by Mail ballot?

- You request an application for vote by mail ballot
- We send you an application with instructions
- You fill out the application and send it to us.
- We enter the vote by mail application into the voter registration system.

- We send you the vote by mail ballot packet with instructions.
- You vote the ballot and seal it in the ballot envelope.
- You provide the sealed ballot envelope to us with applicable affidavits in the mail envelope provided.
- We receive the mail envelope and log receipt in the voter registration system.
- We keep the ballot in the sealed

envelope until judges review it.

- Election judges open the sealed ballot envelope
- The ballot is scanned into the vote by mail ballot system.
- After the polls close the scanned ballots are tabulated.
- Preliminary Vote by Mail ballot results are reported to the public as part of the precinct results after the polls close on Election Day.

## **Vote by Mail Balloting**

### Who Can Vote by Mail?

Any registered voter in Macoupin County is eligible to cast a vote by mail ballot, without specifying a reason why they will be absent from the polling place on Election Day. Voters who registered by mail and did not provide sufficient proof of identity will be notified by the County Clerk that their registration is not complete. They will be ineligible to vote until they provide the required proof of identity at the polling aplace on Election Day or when requesting a vote by mail ballot.

### Can I Vote Absentee?

Illinois law has changed the name of absentee voting to voting by mail. If you want to vote absentee, you will now do it as a vote by mail.

### How do I apply to vote by mail?

You can request an application to vote by mail in many different ways. You can come in person to the Election office, send in a request by mail, call (217) 854-3214 ext 918 or apply online at MacoupinVotes.gov.

The Election office will need the voter's name, residence adress, mailing address and date of birth at the time of request.

### What's the deadline to apply to vote by mail?

The deadline is Thursday, Oct. 31 by 4:30 p.m. The Election office cannot mail a ballot to you after that time.

### How to Vote by Mail

**Step 1 :** Once you have applied and returned your signed application, the Election's office will mail you your vote by mail ballot packet. The packet–including a ballot, instructions on how to fill out your Vote by Mail ballot, certificate envelope, and a return mailing envelope with prepaid postage–will be mailed to the voter.

**Step 2:** Upon receipt of the vote by mail ballot packet, follow all instructions on how to vote and return the ballot to the County Clerk's Office. Make sure to seal just your ballot in the secrecy envelope and place the secrecy envelope and certification card in the return envelope.

### What is the deadline to return my ballot to the Election office?

Returned vote by mail ballots must be postmarked by Tuesday, Nov. 5, and must be received by the Election Office within 14 days of Election Day. If you want to personally deliver your ballot to the Election office, it must be received by no later than 7 p.m. on election day. You may authorize any person to return your ballot to the election authority, as long as you have signed the affidavit on the ballot envelope affirming that authorization was given to deliver the ballot.

## Can I receive assitance in voting my ballot?

If you receive assistance in voting your ballot, the name and address of the individual providing the assistance must be placed on the ballot certification card. Remember that a candidate is NOT allowed to assist a voter unless the candidate is a spouse, parent, child or sibling of that voter.

### **Military and Overseas Voting**

Members of the Uniformed Services and their family members or U.S. citizens residing overseas whose last known address is in Macoupin County and wish to vote by mail may do so by completing and mailing an FPCA (Federal Post Card Application). By completing this application, you will automatically be sent a vote by mail ballot for one calendar year.

### **Vote by Mail Ballot Integrity**

#### It is illegal to:

- Make a false statement to obtain a vote by mail ballot or solicit someone to do so
- Vote a Vote by Mail ballot unless you qualify for one
- Have a candidate assist you in voting unless the candidate is a spouse, parent, child or sibling of that voter.

#### Do not let anyone:

- Mark your ballot, or unduly influence your ballot selections, unless you require assistance. Individuals who cannot assist voters include the Voter's Employer or Agent of that Employer, or Officer or Agent of the Voter's Union.
- On your behalf, sign your name to the Application for a Vote by Mail Ballot and/or certificate envelope. By law, the Macoupin County Clerk's Office compares the facsimile signature at registration with the signature provided on the Application for Vote by Mail Ballot and certificate envelope.

## **Track Your Vote by Mail Ballot**

### Track Your Ballot's Return To Election Office And See If It Was Counted

- **1.** Visit www.macoupinvotes.gov/checkmyballot/. Click "Ballot Tracking Signup Page."
- 2. Enter your name, date of birth and zip code.
- **3.** You will be able to see notifications on when your ballot will be mailed to you, delivered back to the Election office and then the date it is received.

- **4.** You will also be able to see if your ballot was counted (accepted) or rejected.
- 5. If you would like, you can also sign up for email, text and/ or phone call notifications regarding your ballot's delivery back to the office and whether it was counted or not. Just check the box next to the statement that you would like to receive those notifications and enter your email and/or phone number.

## **How Do I Vote Early?**

### WHAT IS EARLY VOTING?

Registered voters may cast a ballot prior to Election Day without having to provide a reason for wanting to vote early. This ballot is cast by personal appearance at the Macoupin County Voting Center office or at a location set up by the County Clerk.

#### WHEN DOES EARLY VOTING OCCUR?

Early voting runs through Nov. 4.

#### WHERE CAN PEOPLE VOTE?

People may vote at the Macoupin County Voting Center, located east of the Old Macoupin County Jail, Monday through Friday, 8:30 a.m. to 4:30 p.m., Sept. 26-Nov. 4. Special evening and Saturday hours are listed below.

### IF I VOTE EARLY, BUT CHANGE MY MIND, MAY I VOTE ON ELECTION DAY?

No. The law prohibits a person who voted during the early voting period from voting again on Election Day.

### ARE POLLWATCHERS ALLOWED AT EARLY VOTING SITES?

Yes. Just as with a regular polling place on Election Day, pollwatchers may be appointed to observe early voting by personal appearance at each permanent and temporary polling place where early voting is conducted.

### WHAT ARE THE SAFEGUARDS AGAINST VOTER FRAUD?

Election judges will compare the voter's signature with the signature from when the voter registered.

The votes cast during the early voting period will not be counted until after the polls close on Election Day.

### WHAT IS THE REASON FOR EARLY VOTING?

A major reason for early voting is to encourage greater participation in the election. People who travel for business, work long hours or are otherwise inconvenienced by the hours the polls are open may find it easier to vote early.
