


Post Election Report

Near Record Turnout in Last Forty Years

Right at 75% turnout, the 2024 Presidential General Election was a near record in the last forty years. The current record is the 2020 General Election with just shy of 76% and before that, the 1992 General Election at 75.4%. This is the first time since 2012 that there has been a decrease in turnout from the previous Presidential Election.

Voter Registration Continuing to Remain Constant

Since 2010 when Pete took office and began consistent voter file maintenance again, the number of registered voters in the county has remained between 30,000 and 32,000. Considering online voter registration and automatic voter registration both went into effect in that same time period, this demonstrates that the voter rolls are being maintained and is kept as clean as legally possible.




Near Record Number of Votes Cast Before Election Day

In 2020, the number of votes cast before election day significantly increased from 2016 when it was 16% to 38%. This was considered to mainly be because of COVID and the numbers would go back to pre-COVID levels in 2024. Instead, 2024 nearly matched 2020 with 33% These voting types include early voting in person, vote by mail ballots, military and overseas voting, nursing home votes, and grace period registration. Grace period registration is when a voter registers or changes their registration after the deadline and must cast a ballot the same day.


2024 Turnout Broken Down by Vote Type








Record High In Person Early Voting and Mail Return Rate






Turnout by Age and Gender

■Female ■ Male






MacoupinVotes.gov received some significant traffic over the course of the primary. In the last 90 days, there were over 22,000 visitors, almost equal to the complete turnout. Election Day was obviously the day with the most visitors, the second being November 10th, which happened organically as there is nothing we are aware would have caused that spike. There were over 355,000 impressions on the site over the 90 days, with over 50,000 Interestingly, nearly 3 out of every 4 voters came to the site from an organic search as opposed to social media or direct links.

Top Viewed Content Online



Election Judges Worked Compared to Full Slate

Between precinct consolidation and two raises in less than 3 years for election judges, the 2024 General saw the highest percentage of judge spots filled since the 2008 General Election. Hopefully, this trend will continue in future elections and anyone interested in serving as an Election Judge is encouraged to reach out to the Election Office. One of the successes we've had is the high school judges program, with 20 of the judges serving this election being student judges.

Vote by Mail Rejection and Provisional Processing

Each election, election judges review vote by mail ballots to verify the identity of the voter and ensure it meets the statutory requirements. Voters whose ballots are rejected and given the chance to cure their ballot and get it counted. For the first time, we are publishing those statistics in Macoupin for those who might be interested.

Ballots that were flagged by Election judges – 21

Reasons why:

Signatures were deemed to not match by judges - 12

Voters who forgot to sign their certification card - 9

Number of ballots cured and those ballots counted – 11 Number where voter did not seek to cure their ballot - 10

Each election, some voters are required to vote provisional ballots which allow for the Election office to review circumstances regarding their ballot and if they should be counted. For the first time, we're releasing the statistics on how many provisionals were cast and counted. While turnout was near record high, there were still a low amount of provisional voters.

28 provisionals cast

16 provisionals were counted

1 was a ballot from a voter who said they had inserted a blank ballot into the tabulator and wanted to vote again. This ballot did not count.

6 were voters who were either never registered or had their registration cancelled and did not come to Voting Center to grace period vote. These ballots did not count but these voters are now registered to vote.

5 were voters who had address changes that changed their precinct and they did not come to Voting Center to grace period vote. Their registration has been updated for future elections.

Post Election Audit Retabulation Results

After each election, the Election office is required to re-tabulate the election results after each election and before the official canvass. The State Board of Elections randomly selected 5% of precincts and early voting tabulators to be retabulated. Each ballot is re-run through the same machine after the machine is reset and tested to ensure that the same results are counted. If there are discrepancies, the Election office must investigate and report their findings tot eh State Board of Elections. This election, the Macoupin Retab was completed on November 12th and there were no discrepancies found between the results as posted and the retabulation. More statistics are below.
