A Message to Voters

ONCE AGAIN IT IS MY PLEASURE to provide Macoupin County voters with this Voter Information and Election Guide for the upcoming 2026 midterm primary election.

Within this guide, you will find all the information you need to participate in this important aspect of American democracy. In addition to sample ballots, you'll find information about voter registration, voting procedures, early voting and voting by mail.

The privilege of voting is a uniquely American experience. It is the foundation of our democracy and the warranty that protects our freedom. Despite the importance of the electoral system, many Americans, including Macoupin County citizens, choose to not participate, particularly when it comes to primary elections.

Primary elections traditionally generate less voter interest and participation than general elections. That is particularly true for non-presidential primaries such as the one coming up in March. For the last presidential primary in 2024, only 19 percent of the county's registered voters cast ballots. That compares with 75 percent who voted in the general election a few months later.

Turnout for midterms elections, attract even less voter interest. The 2022 gubernatorial primary, for example, drew only 19.3 percent of the county's nearly 32,000 registered voters, while the general election later that year attracted only 58 percent of the county's registered voters.

As the administrator of Macoupin County elections, those numbers are disheartening, especially when I take into consideration the expense, time, effort, and hard work that goes into ensuring that every election cycle runs efficiently. My staff and

I are diligently ensuring that an opportunity to vote is extended to each and every legal voter in Macoupin County, and that each vote is fairly counted.

I understand some voters shy away from primary elections because they do not wish to declare a party preference in order to receive a ballot. It can be argued, however, that the primary is equally important as the general election. Primary voters determine who will be candidates for general election next fall. In Macoupin County, only one party has fielded a slate of candidates for County Sheriff, meaning the primary will most likely determine who will become County Sheriff next fall. Likewise, the primary will be the only opportunity Macoupin voters will have to have a voice in selecting who the candidates will be to step into the Senatorial seat held by Sen. Dick Durbin for decades. An astonishing 10 candidates seek the Senatorial nomination on the Democrat side of the ballot, while six names appear on the Republican ballot. Primary voters also will select or confirm candidates for State Senator, State Representative, County Clerk and County Treasurer, County Board seats and precinct committee persons. Each of these offices are important and will have an impact on the daily lives of citizens and determine the direction of our government over the next several years.

For this election, Brighton voters may request a non-partisan ballot to vote on a public question.

I'm proud to say election results in Macoupin County have never been questioned in the time I have served as your County Clerk. That's testament to the hard work and dedication of our Election Office staff and election judges who commit themselves to training and put in long hours of public service on Election Day and/or during early voting opportunities. In Macoupin County, we use up-to-date voting technology that electronically tabulates votes but also maintains a paper trail to confirm election results should they ever come under question.

Since our voting machines and tabulating equipment are not connected to the internet in any way, Macoupin County elections are safe from cyberattack or hacking.

If you have further questions or need additional information, I encourage you to contact my office at (217) 854-3214, extension 918, or visit our comprehensive election website at www.macoupinvotes.gov. The state of the art website allows voters to check the status of their voter registration, find the polling place for their precinct, view sample ballots and obtain other information. On election night, the website will be updated regularly with election results for Macoupin County so voters will know the outcome of local races and ballot issues as soon as ballots are counted.

From finalizing ballots and responding to vote-by-mail requests to setting up polling places and vote counting equipment, administering any election is a mammoth undertaking. As your County Clerk, it has again been my pleasure to work with staff members, party officials, candidates and public officials to make sure every aspect of the 2026 Primary Election runs smoothly.





Notice of Election

Voter Bill of Rights

You have the right to:

- ❖ Cast your ballot in a non-disruptive atmosphere free of interference.
- ❖ Vote if you're in line at the polling place by 7 p.m.
- ❖ Be a provisional voter if there is a question about your registration status or your eligibility to vote in the election.
- ❖ Vote a federal ballot at your old polling place if you have moved within 30 days of the election.
- ❖ Request assistance in voting, if needed.
- ❖ Bring this voter's guide or sample ballots into the voting booth, but take them with you when you finish voting.
- ❖ Protect the secrecy of your ballot by using the ballot secrecy folder provided.
- ❖ Receive a new ballot if you make a mistake or change your mind.
- ❖ Check for voting errors (overvotes) after marking your ballot in a private and independent manner.
- ❖ Have your ballot counted fairly and impartially.

Am I Eligible to Vote?

Am I eligible to vote?

In order to be eligible to vote in Macoupin County, you must register. The County Clerk's Office processes all voter registration applications for Macoupin County residents. The last day to register for this Election is February 17. See the 'Grace Period Balloting' section on page 6 for more information.

Who can register to vote?

You may register to vote if:

- You are a U.S. citizen and 18 years of age by date of next election and

- Lived at your current Macoupin County address for at least 30 days immediately prior to the next election.

Two forms of identification are required when registering with a deputy registrar.

At least one of the two forms must show your current name and address.

Only one form of identification may be a piece of mail postmarked within the past 30 days which has been addressed and delivered to you.

Acceptable forms of identification include, but are not limited to the following:

- Driver's License
- Birth Certificate
- State ID Card
- Social Security Card
- Utility Bill
- Employee ID Card
- Checkbook
- Student ID Card
- Library Card
- Insurance Card
- Credit Card

Check Your Voter Registration Status

To check your voter registration status:

- Go to www.macoupinvotes.gov
- Hit 'Voter Lookup' underneath the photos of Macoupin sites.

- Enter the information required to check if you are registered to vote.

If your information appears on screen, you are registered to vote. If it does not, try your legal name or previously used name to see if your registration is outdated.





Grace Period Balloting

If I Didn't Register or Forgot to Change My Registration Before the Deadline, Can I Still Vote?

If you were unable to register to vote or change your address prior to the close of registration, you can still register and vote through grace period voting. The close of registration for this election is February 17.

Grace period individuals may register to vote or change their address starting February 18 through Election Day.

Grace period voting is only available at the Macoupin County Voting Center, east of the Old Jail. Hours are Monday through Friday, 8:30 a.m. to 4:30 p.m.

Two forms of identification are required to register or change your registration during grace period voting:

- At least one of the two forms must show your name and current address,
- And only one form of identification may be a piece of mail addressed and delivered to you.

The second form must show your name. These forms of identification shall include, but not be limited to:

- ❖ Driver's License
- ❖ Social Security Card
- ❖ Birth Certificate
- ❖ Employee ID
- ❖ Student ID Card
- ❖ Credit Card

- ❖ Library Card
- ❖ Insurance Card
- ❖ Utility Bill
- ❖ Checkbook
- ❖ Telephone Bill
- ❖ State ID Card

Grace period voters must vote on the same day they register to vote. They may not vote at the polls on Election Day.

Vote Early

Cast your ballot at the County Voting Center before Election Day. You just need to bring a photo ID. See 'Early Voting' on page 11 for more information.

Vote By Mail

Simply call our office at (217) 854-3214 ext 918 or visit our website at www.macoupinvotes.gov to request your absentee ballot

and vote in privacy before Election Day. See page 12 for more information.

Vote at Your Precinct on Election Day

Election Day is your last chance to vote! To find your polling place, see 'Where Do I Vote on Election Day?' on page 10.

Be sure we have your current information on your registration. See 'Am I Eligible to Vote?' on page 5 for more information.

Make sure to show up from 6 a.m. to 7 p.m. to vote. To avoid lines and congestion at your precinct, you may want to vote in the 10 a.m. to 4 p.m. non rush hour time frame of the day.



Voter Responsibilities

Each registered voter in this state should:

1. Familiarize herself or himself with the candidates and issues.
2. Maintain with the Elections Office their registration with a current name and address.
3. Know the location of her or his polling place and its hours of operation.

4. Bring proper identification to the polling station in case it is needed.
5. Familiarize herself or himself with the operation of the voting equipment in his or her precinct.
6. Treat precinct workers with courtesy.
7. Respect the privacy of other voters.
8. Report any problems or violations of Election laws to the County Clerk's office.
9. Ask questions, if needed.
10. Make sure that her or his completed ballot is correct before leaving the polling place.



Casting Your Ballot

Optical Scan Voting: As Easy as 1,2,3


1. Receive your ballot

Enter the polling place and give your name and address to an election judge. Complete and sign an Application to Vote. Upon verification, the election judge will give you:

- ❖ A paper ballot
- ❖ A privacy cover
- ❖ A pen

2. Enter the voting booth and mark your ballot

Enter the next available voting booth. To vote the optical scan ballot, completely fill in the oval to the left of the candidate or public question of your choice. Be sure to mark both sides of your ballot if needed. If you make a mistake marking your ballot, return it to an election judge to receive a new ballot.



3. Vote!

Cover your ballot with the privacy sleeve and insert the ballot into the ballot tabulator. The Optical Scan System complies with the Help America Vote Act (HAVA) to provide voters an opportunity to check for and correct ballot errors (for example, casting more votes for an office than allowed results in an overvote). If an error is detected, the system will gently beep and give you the option to accept the ballot as is (the overvoted office will not count) or you may return the ballot to an election judge and receive a new ballot.

- ❖ The ballot tabulator will notify you if you have overvoted an office or undervoted an office. Many voters intentionally skip offices which they do not care to vote in, but rarely intentionally vote for more candidates than allowed in any given office. You can either count the ballot as is or go back and check your ballot.
- ❖ The ballot tabulator will notify you if you have inserted a blank ballot or one that is perceived to be blank because it was not marked properly.
- ❖ The “paper trail” provided by this system of voting is not a receipt for the voter, but instead an actual ballot which can be recounted when necessary to insure the integrity of the system.

Where Do I Vote?

During early voting, you can vote at the Macoupin County Voting Center, 227 East First South St., Carlinville (directly south of the Macoupin County Courthouse). Find out more about early voting opportunities on page 11.

On Election Day you should vote where you live. If your

voting registration is up-to-date, you can refer to your voter information card for your precinct number and the polling place location, or use the voter look-up feature at macoupinvotes.gov.

However, if you've moved and have not updated your voter registration information,

you will be required to vote a provisional ballot at your new polling place. You also can come to the Macoupin County Voting Center during the grace period, change your registration and vote at the same time. See page 6 for more information.



Find Your Polling Place Online

1. Go to www.macoupinvotes.gov.
2. Click on the "Voter Look-up" button beneath the Welcome banner.
3. Enter your voter registration information. You must enter the information exact-

ly as it appears on the voter file, which is exactly as you wrote it when you register. If your registration information does not immediately appear, try your legal name or old address

4. Your polling place, its address and the ability to

Google map the location will appear on the screen. Clicking on the name of the polling place (it appears in red), will take you to a photo of your polling place and Google Maps directions to location.

How Do I Vote Early?

What is Early Voting?

Registered voters may cast a ballot prior to Election Day without having to provide a reason for wanting to vote early. This ballot is cast by personal appearance at the Macoupin County Voting Center office or at a location set up by the County Clerk.

When does Early Voting Occur?

Early voting runs through March 16.

Where can people vote?

People may vote at the Macoupin County Voting Center, located east of the Old Macoupin County Jail, Monday through Friday, 8:30 a.m. to 4:30 p.m., February 5 through March 16. Special evening and Saturday hours are listed below.

If I Vote Early, but change my mind, may I vote on Election Day?

No. The law prohibits a person who voted during the early voting period from voting again on Election Day.

Are pollwatchers allowed at Early Voting sites?

Yes. Just as with a regular polling place on Election Day, pollwatchers may be appointed to observe early voting. by personal appearance at each permanent and temporary polling place where early voting is conducted.

What are the safeguards against voter fraud?

Election judges will compare the voter's signature with the signature from when the voter registered.

The votes cast during the early voting period will not be counted until after the polls close on Election Day.

What is the reason for Early Voting?

A major reason for early voting is to encourage greater participation in the election. People who travel for business, work long hours or are otherwise inconvenienced by the hours the polls are open may find it easier to vote early.

Vote-by-Mail Now Permanent

The state has approved giving voters the choice of receiving a mail ballot for each election without applying each time.

Voters wanting to be placed on the permanent vote-by-mail list are required to apply for inclusion on the list. Once they apply, they will remain on the list and have a ballot mailed to them for each election going forward. If the voter requests to be removed from the list, there is a change to their registration, or they move out of the county, they will be removed from the list and will not longer receive a vote-by-mail ballot for future elections.

Those wanting to apply, can choose to just

apply to receive a ballot for general elections and consolidated elections, or they can choose to also receive a primary ballot for the party they indicate on their application.

"I'm very happy that voters who have been voting by mail for years will now have the options of requesting a ballot automatically if they so choose," said County Clerk Pete Duncan. "I'm all for giving voters more choices on how they want to vote. Those who want only to vote in person at their polling place on Election Day can continue to do that. For those who do apply to vote-by-mail for each election, this is an option that may make sense for you."

This will be more cost-efficient for elections going forward. There are quite a few voters in Macoupin County who have voted by mail in each election for many years. Each election, the Election Office probably has mailed them an application, and they've mailed it back to get their ballot. While it's not a lot of postage and costs, eliminating that step by adding the voter to the permanent vote-by-mail list does save some money. It also helps our Election Office, since we will have a head start on vote-by-mail ballot mailing. Since it will be known going in how many permanent mail ballots are going out, we can get them to voters right away.



Vote-by-Mail Ballot Processing

How are Vote-By-Mail ballots processed?

- ❖ The voter requests an application for a vote-by-mail ballot.
- ❖ The Election Office sends the voter an application with instructions.
- ❖ The voter fills out the application and sends it back to the Election Office.
- ❖ The Election Office enters the vote-by-mail application into the voter registration system.

- ❖ The Election Office sends the voter a vote-by-mail packet with instructions.
- ❖ The voter votes the ballot and seals it in the ballot envelope.
- ❖ The voter uses the postage-paid return envelope to send the sealed ballot envelope along with applicable affidavits to the Election Office.
- ❖ The Election Office receives the envelope and logs receipt of the ballot into the voter registration system.
- ❖ The Election Office keeps the ballot in the sealed envelope until election judges

review it.

- ❖ Election judges open the sealed ballot envelope.
- ❖ The ballot is scanned into the vote-by-mail system.
- ❖ After the polls close on Election Day, the scanned vote-by-mail ballots are tabulated.
- ❖ Preliminary vote-by-mail ballot results are reported to the public as part of the precinct results after the polls close on Election Day.



Vote-by-Mail Balloting

Who can vote by mail?

Any registered voter in Macoupin County is eligible to cast a vote by mail ballot, without specifying a reason why they will not be able to vote in person on Election Day. Voters who registered by mail and did not provide sufficient proof of identity will be notified by the County Clerk that their registration is not complete. They will be ineligible to vote until they provide the required proof of identity at their polling place on Election Day, or when requesting a vote by mail ballot.

Can I vote absentee?

Illinois law has changed the name of "absentee voting" to "voting by mail." If you want to vote absentee, you will now cast a vote-by-mail ballot.

How Do I Apply to Vote by Mail?

You can request an application to vote by mail in many different ways. You can come in person to the Macoupin County Voting Center, 227 East First South St., Carlinville, send in a request by mail, call (217) 854-3214, ext. 918, or apply online at macoupinvotes.gov.

The Election Office will need the voter's name, residential address, mailing address, and date of birth at the time of the request.

What's the deadline to apply to Vote by Mail

The deadline to apply for a vote-by-mail ballot is March 12 by 4:30 p.m. The Election Office cannot mail a ballot after that deadline.

How to vote by mail

Step 1: Once you have applied and returned your signed application, the Election Office will mail you your vote-by-mail ballot packet. The packet—containing a ballot, instructions on how to complete your vote-by-mail ballot, a certificate envelope, and a return mailing envelope with postage paid—will be mailed to the voter.

Step 2: Upon receipt of the vote-by-mail ballot, follow all instructions on how to vote and return the ballot to the County Clerk's Election Office. Make sure to seal just your ballot in the secrecy envelope, and place the secrecy envelope and certification card in the return envelope before mailing to the Election Office.

What is the deadline to return my vote-by-mail ballot?

Returned vote by mail ballots must be postmarked by Tuesday, March 17, and must be received by the Election Office within 14 days of Election Day. If you want to personally deliver your ballot to the Election Office, it must be received no later than 7 p.m. on Election Day. You may authorize any person to return your ballot to the election authority, as long as you have signed the affidavit on the ballot envelope affirming that authorization was given to deliver the ballot.

Can I receive assistance in voting my ballot?

If you receive assistance in voting your ballot, the name and address of the person providing the assistance must be placed on the ballot certification card. Remember that

a candidate is NOT allowed to assist a voter unless the candidate is a spouse, parent, child or sibling of the voter.

Military and overseas voting

Members of the Uniformed Services and their family members of U.S. citizens residing overseas whose last known address was in Macoupin County and who wish to vote by mail may do so by completing and mailing an FPCA (Federal Post Card Application). By completing this application, you will automatically be sent a vote-by-mail ballot for one calendar year.

Vote-by-Mail ballot integrity

It is illegal to:

- ❖ Make a false statement to obtain a vote-by-mail ballot or solicit someone to do so.
- ❖ Vote a vote-by-mail ballot unless you qualify for one.
- ❖ Have a candidate assist you in voting unless the candidate is the voter's spouse, parent, child or sibling.

Do not let anyone:

- ❖ Mark your ballot, or unduly influence your ballot selections, unless you require assistance. Individuals who cannot assist voters include the voter's employer or an agent of that employer, or an officer or agent of the voter's union.
- ❖ On your behalf, sign your name to the application for a vote-by-mail ballot and/or certificate envelope. By law, the Macoupin County Clerk's Office compares the facsimile signature at registration with the signature provided on the application for a vote-by-mail ballot and the certificate envelope.



Track Your Vote-by-Mail Ballot

Track Your Ballot's Return to Election Office And See If It Was Counted

1. Visit www.macoupinvotes.gov/checkmyballot.
2. Click "Ballot Tracking Signup Page."
3. Enter your name, date of birth and

zip code.

4. You will be able to see notifications on when your ballot will be mailed to you, delivered back to the Election office and then the date it is received.
5. You will also be able to see if your ballot was counted (accepted) or rejected.

6. If you would like, you can also sign up for email, text and/or phone call notifications regarding your ballot's delivery back to the office and whether it was counted or not. Just check the box next to the statement that you would like to receive those notifications and enter your email and/or phone number.

Election Security

Election security is a top priority for all election authorities and the Macoupin County Clerk's office has continued to employ effective and forward-thinking cybersecurity measures to further strengthen our county's elections systems and safeguard our elections infrastructure against any malicious cyber activity.

Since the 2016 Presidential Election, there have been many questions and stories about how secure our Elections are and can our votes be hacked. When it comes to Macoupin County, we wanted to give you the hard facts about how our elections are secure.

- None of our voting machines are ever connected to the internet, either in the polling place or when votes are being counted, meaning they can never be hacked

- All machines are locked and sealed to

prevent any kind of tampering or system interference

- All ballots cast have a paper trail. Whether you vote a paper ballot or on the touchscreen, there is a paper trail of how your vote was cast

- All voting machines are tested before the Election with a test deck of ballots being voted on machines and then tabulated to ensure the machine results are correct and match the test deck of ballots

- While voting is occurring, Election judges periodically inspect the equipment to ensure there has been no tampering or damage

- Election judges at the polling place confirm that there are zero votes cast at the opening of voting and must compare the number of ballots cast to the number of voters

that applied to vote at the end of the day

- Poll watchers are allowed to observe all early voting and Election Day polling locations

- After the Election, a retabulation of selected precincts by the State Board of Election will be done to ensure that the reported results match up to the ballots cast

The Macoupin County Clerk's office takes ensuring every vote is counted and counted correctly seriously in Macoupin. When it comes to cyber security, the County Clerk's office has taken numerous steps to enhance our security processes. While we don't want to detail them all publicly for those who may want to interfere to see, we have and will continue to try and stay one step ahead of any attempts to disrupt Macoupin's Elections.



How Do Primaries Work?

How do primaries work?

Primary elections decide which candidate will run for each party during the general election. Illinois holds a closed primary, which means voters must choose a single party ballot on the day of a primary election.

Why do I have to choose one party's ballot?

State law requires you can vote in either the Republican or the Democratic primary, but not both.

For example, you cannot vote in the Republican primary for President but in the Democratic primary for State's Attorney.

What if I don't want to say which party's ballot I want?

If there are public questions where you live, you will be able to get a non-partisan ballot. However, a non-partisan ballot will not have any candidates on it, just public questions. If there are no public questions on the ballot where you live, to vote you must pick one party's ballot.



Become an Election Judge

What are judges of election?

Judges of election are responsible for the administration of election procedures in the polling place on election day. They are in the position of ensuring that the election process is administered fairly and in accordance with our laws.

What qualifications are needed to be an election judge?

- ❖ Be a citizen of the United States.
- ❖ Be of good repute and character.
- ❖ Be able to speak, read and write the English language.
- ❖ Be of good understanding and capable.
- ❖ Not be an elected committeeman.
- ❖ Be registered to vote in Macoupin County.
- ❖ Each Election Judge is required to declare their party preference so they can be assigned accordingly. (See how judges are selected in the following section.)

How are judges selected?

Election Judges are chosen by the County Clerk and by the Party Chairpersons. The party which cast the highest average number of votes at the most recent three gubernatorial elections in the precinct shall be represented by three judges, the party which casts the second highest number of votes at the most recent three gubernatorial elections in the precinct shall be represented by two judges.

How are election judges trained?

Before each election, several election judge training schools will be held. This course covers the duties and responsibilities of election judges and an examination which tests reading skills, ability to work with poll lists, ability to add and knowledge of election laws governing the operation of polling places is given every two years. Judges who have attended and completed the class will receive \$160 for their duties on election day. Judges who have not attended and completed the class will receive \$150 for their duties on election day.

What are some of the duties of judges of election?

- ❖ Open and close the polls.
- ❖ Be responsible for election materials.
- ❖ Ensure that only qualified voters are permitted to vote and that each qualified voter is permitted to vote once and only once.
- ❖ Give instructions in the method of voting when requested by a voter.
- ❖ Give assistance to illiterate and physically disabled voters.
- ❖ Maintain order in the polling place throughout the day.
- ❖ Tally the votes after the polls are closed; and to certify the election results in that precinct.

How may I become an election judge?

Contact the County Clerk's office by phone or email and express your interest in serving as a Judge of Election. Election judges are vital to ensure efficient and honest elections to which voters are entitled in a democratic society.
